

## OUR FOCUS ON PACKAGING CARE

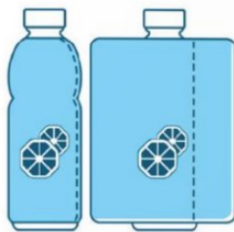
It is our intention to comply with current European regulations and to remain up-to-date in this regard. Therefore, we can assure you that the packaging of our products is correctly marked according to Legislative Decree No. 116 of 3 September 2020 "Implementation of Directive (EU) 2018/851 amending Directive 2008/98/EC on waste and implementation of Directive (EU) 2018/852 amending Directive 1994/62/EC on packaging and packaging waste".

Decree No. 116/2020 requires that all packaging be *"appropriately labelled in accordance with the modalities established by the applicable UNI technical standards and in accordance with the determinations adopted by the Commission of the European Union in order to facilitate the collection, reuse, recovery and recycling of packaging, as well as to give correct information to consumers on the final destinations of packaging. Producers are also obliged to indicate, for the purpose of identifying and classifying packaging, the nature of the packaging materials used, based on Commission Decision 97/129/EC"*.

The subject of Article 219 paragraph 5 of the Decree concerns environmental labelling relating to the packaging itself and is independent of any other labelling obligation relating to the product contained to be displayed on the packaging. Furthermore, the self-adhesive label on the packaging is disposed of according to the nature of the primary packaging, since the Decree does not concern the self-adhesive material itself but the overall packaging of which it is a component. This means that they must be disposed of differently depending on the nature of the overall packaging. Recyclability and/or disposal will therefore follow the same procedure as the packaging to which the label is attached.
